Local Approval Sought on Master Plan for Curry County State Parks

❖ Upcoming Board of County Commissioner's Hearing

On August 19, 2002 the Curry County Board of Commissioners will be holding a public hearing on the Curry County State Parks Master Plan. The Commissioners hope to make a formal recommendation on this master plan at the hearing. Commission recommendations can include suggested conditions or changes to the master plan. Upon agreement, the master plan can be adopted as a state rule. The final step, which will occur later this year, is when the county adopts the plan into the county's comprehensive plan.

Oregon Parks and Recreation Department (OPRD) developed a draft plan for Curry County State Parks in 1999. Since that time, over 19 public meetings have been held throughout the county regarding the master plan. Many people have provided important input and have helped to shape the plan. OPRD has submitted the plan to the county for land use review and approval. Upon local adoption of the master plan, all the uses outlined in the plan will be granted conceptual approval.
