# **Oregon Parks and Recreation Submits Draft Master Plan to County for Land Use Approval**

### ❖ **A Brief History of the Draft Plan**

<b>Summer 1999</b>	OPRD Develops Draft Master Plan with public input
<b>November 1999</b>	Oregon Parks and Recreation Commission directed staff to initial state rule making and local land use adoption of the plan
<b>Summer 2001</b>	OPRD held public meetings and updated the Master Plan
<b>September 2001</b>	Oregon Parks and Recreation Commission approved updates and directed staff to initiate rule making and local land use adoption again.
<b>May 2002</b>	OPRD submits land use application to Curry County

### ❖ **What to Expect this Summer**

<b>June 2002</b>	OPRD to initiate State Rule Making Process.
<b>June 6, 2002</b>	Planning Commission to make recommendations on the Draft Master Plan
<b>Summer/Fall 2002</b>	Board of County Commission Hearing (to be scheduled)

### ❖ **What Will Happen at the Planning Commission Meeting?**

The County Planning Director will present the staff report on the master plan. State Park staff will then provide the Planning Commission a brief overview of the plan, the planning process and answer any questions they may have. The Planning Commission will then open to floor to public comment. This meeting will be an excellent meeting to voice your concerns or issues relating to master plan to the Planning Commission because they will be making recommendations to the Board of County Commissioners. The Board of County Commissioners will eventually make the final land use decision. This decision will determine what and how park facilities can be developed in state parks. Please note-- this hearing will not occur until later this summer and will be notified beforehand.
